- Internal compliance policies and their alignment with external regulations.

Module 3: Implementing an Ethical Procurement Framework Key Topics:

- Crafting policies for conflict of interest, transparency, and accountability.
- Defining roles and

responsibilities in upholding compliance. Module 4: Supplier Relationship Management and Ethical Considerations Key Topics: · Selecting and evaluating suppliers based on ethical standards. · Mitigating risks in supplier interactions (e.g., gifts, hospitality, favouritism). · Conducting supplier audits and compliance reviews. Module 5: Compliance Monitoring and Reporting Mechanisms Key Topics:

· Implementing monitoring tools, including data analytics and e-procurement platforms. · Establishing whistleblower policies and reporting channels. · Conducting regular compliance audits and follow-up actions. Module 6: Fostering a Culture of Ethics and Accountability Key Topics: · Leadership's role in promoting ethical behaviour in procurement. · Training and awareness programs for procurement teams. · Incentives and disciplinary measures to reinforce compliance.

## METODOLOGÍA

This training will employ adult learning techniques such that participants can discover and internalise the practical application of various concepts taught. This will be achieved by the following facilitation methods: 1. The training package will also be designed to consider participants' backgrounds and prior knowledge of subject areas, which aligns with UTG's sound adult-learning pedagogical principles. The learning activities will be delivered interactively to ensure the achievement of the learning objectives.
