## ARRIÈRE PLAN

The overall aim of this training program is to strengthen country-level digital health governance and health workforce capacity to implement national digital health strategies, architectures, standards, information infrastructures and health emergency preparedness technologies and equip participants with the skills needed to adopt a national planning approach to digital health.

## OBJECTIFS DE L'ÉVÉNEMENT

- **Develop** a holistic, enterprise planning approach to digital health;
- **Utilize** relevant WHO and ITU toolkits and Global Goods applications to support the implementation of digital health activities;
- **Define** and critique trade-offs among investments and activities;
- **Demonstrate** a range of technical skills related to digital health systems strengthening, including landscaping the enabling environment, refining a digital health strategy, and structuring partnerships to enable implementation of national digital health systems
- **Design** a plan to support a robust digital health enterprise architecture that is scalable, sustainable, and interoperable; and
- **Develop** the foundation for self-efficacy and leadership skills to manage and advocate for an enterprise planning approach aligned with specific health challenges and opportunities in-country.

## CONTENU ET STRUCTURE

A participant is expected to cover all of the modules to successfully complete the training and receive the certification.
